REVISED ADMISSION NOTICE

Registration Forms for admission into **LKG** for the wards of IFFCO employees for the **Session 2021-22** are available in the school office between **01.03.2021 to 15.03.2021**. The registration form can be obtained after payment of **Rs.100/- (Rupees one hundred only)** in **A/c No. 1700** of **IOB, Musadia Branch** and showing the money receipt in the school office from **01.03.2021 to 15.03.2021** during school hours (**08:00a.m. to 02:00p.m.**).

25% of the seats as per **RCFCE Act 2009** are reserved for the candidates belonging to weaker sections and disadvantaged group of the society in the neighborhood (**within one K. M. of the school**).

The registration form for weaker section and disadvantaged group will be available in the school office free of cost during the period of submission of supporting document.

- **LKG- 80 seats**
Age limit- The candidate should be born between **01.04.2016 and 31.03.2017** (both days inclusive).
- **Last date for submission** of registration form on **15.03.2021**.
- Date of draw of lottery if required-**30/03/2021** at **11:00 a.m.**
List of selected candidates will be displayed on the school notice board – **31/03/2021**.
- Date of provisional admission of the selected candidates- **01/04/2021 to 12/04/2021**.
- **Documents to be deposited with the form:**
 - (i) Money Receipt
 - (ii) Photocopy of Aadhaar Card is essential for admission.
 - (iii) Photocopy of DOB certificate issued by the competent authority.
 - (iv) B2 size (7cm x 5 cm) photograph of the child along with the parents at the space provided.
 - (v) **For disadvantaged group (SC/ST/SEBC-Non-Creamy Layer)**
 - (a) In case of SC/ST candidates, original & attested photocopy of caste certificate in the name of child seeking admission.

(b) In case of SEBC candidates, recent original & attested photocopy of SEBC certificate in the name of the child seeking for admission and income certificate of the parent issued by local Tahasildar.

(c) Original and attested photocopy of document like electricity bill/water bill/ telephone bill/passport to be produced in support of proof of residence (with in 1 Km of the school). The said documents must be in the name of parents of the ward seeking admission.

(vi) **For weaker section (BPL Card holder)**

(e) Original & attested photo of BPL card in the name of parents.

(f) Original and attested photocopy of document like electricity bill/water bill/telephone bill/passport to be produced in support of proof of residence (with in 1 Km of the school). The said documents must be in the name of parents of the ward seeking admission.

(vii) In case of above two categories the place of residence may be verified by the school authority before issuing the registration form.

2. A (I) Special Category

(a) Disadvantaged group – 15% = 12 seats
(SC/ST/SEBC)

(b) Weaker Section – 10% = 08 seats
(BPL card holders)

2. A (II) General Category - 75% = 60 seats
