## ADMISSION NOTICE FOR NON-IFFCO STUDENTS (REVISED)

Provisional Admission into **Class-XI Science & Humanities** for the wards of NON-IFFCO employees is open for the **session 2025-2026**. The Registration Form will be available in the school office between **10:00 a.m. to 02:00 p.m.** on all working days from **15 January 2025 to 06 February 2025**. The candidates are requested to deposit **Rs. 200/-** in A/c No.- **184001000001700** of **IOB, Musadia Branch (IFSC CODE- IOBA0001840)** and obtain the Registration Form from the school office after submission of a copy of the money receipt.

However, the candidates may download the Registration Form from the website ([www.daviffco.com](http://www.daviffco.com)) and submit the same in the school office with the print out of money receipt of Rs.200/- through online transaction or they may scan the form & money receipt and mail to school ([dav.iffco@gmail.com](mailto:dav.iffco@gmail.com)).

### GUIDELINES

#### SCIENCE

- i. The students who have secured at least 60% (in theory) in the Pre-board/ Term-I will be allowed to register.
- ii. Subjects Offered: Compulsory - English Core, Elective – Physics, Chemistry, Maths/ Hindi, Biology/ Computer Science, Physical Education.
- iii. The candidates will be allowed to choose minimum 4 subjects or maximum five subjects from the elective group. They can choose Hindi in place of Mathematics, Computer Science in place of Biology and Physical Education as the 6<sup>th</sup> subject.

#### HUMANITIES

- i. The students who have secured at least 45% (in theory) in the Pre-board/ Term-I will be allowed to register.
  - ii. Subjects Offered: Compulsory – English Core, Elective – Hindi, History, Economics, Geography, Physical Education, Music.
  - iii. The candidates will be allowed to choose minimum 4 subjects or maximum five subjects from the elective group.
1. **For selection of admission, there will be an aptitude test of class-X standard.**
  2. **The result of the aptitude test will be published on the school notice board/ website and the selection of students for admission will be done strictly according to the merit list.**
  3. a. After publication of the merit list, counseling and provisional admission will be held in the school premises.  
b. The parents have to give an undertaking that the School Authorities can take any action against their ward in case of showing dismal performance in three consecutive tests conducted by the school meant for continuous & comprehensive evaluation (either surprise test or terminal test or both).  
c. In order to ensure a better examination-oriented preparation, it is to be strictly followed that the students have a minimum of 75% attendance in theory and 75% attendance in practical. Parents along with their wards should give an undertaking to ensure this.
  4. The following points are to be noted for provisional admission / counseling.
    - a. Presence of parents on the day of provisional admission.
    - b. The first installment of school fee to be deposited on the day of provisional admission/ counselling. (The fee details will be notified at the time of result publication)

- c. Absence in counseling will lead to forfeiture of admission.
5. The following documents are mandatory after publication of Board Result on the day of final admission:
- Original TC / School Leaving Certificate of the previous school.
  - Original Conduct Certificate from the concerned institution last attended.
  - Original Migration Certificate from the concerned Board.

**N.B:**

- In case of not scoring minimum 70% for Science Stream and 60% for Humanities Stream or failed in Board Examination respectively, the provisional admission stands cancelled.
- In case of failure to take final admission the provisional admission shall stand cancelled automatically and no fee will be refunded.
- Admission will be taken against vacant seats after giving priority to own school students.

- Money Receipt.
- Photocopy of Aadhar Card both student and parent(s).
- Photocopy of DOB certificate issued by the competent authority.
- Mark Sheet of Term-I (AISSE) & Pre-Board.

• **Last date for submission of registration form: 07.02.2025**

• **Date of entrance test: 08.02.2025**

• **Display of the merit list – 10.02.2025**

• **Provisional date of Admission/ Counselling – 11.02.2025 to 12.02.2025**

\*Total tentative annual school fee for the session 2025-2026 is Rs.69,222/-.

\*Likely to undergo minor revision in the tuition fee, which will be collected at the time of final admission.
