Admission into Nursery & Class-I for the wards of IFFCO & Non-IFFCO employees (grandchildren of employees/children of non-employee/children of shopkeepers of Township Market Complex, who are residing in the Township) is open for the session **2026-27**. The Registration Forms will be available in the school office between **10:00 a.m. and 01:00 p.m.** on all working days from **13.02.2026 to 20.03.2026**. Candidates are requested to deposit **Rs. 200/- in A/c No.- 184001000001700 of IOB, Musadia Branch (IFSC CODE-IOBA0001840) through online payment** and obtain the Registration Forms from the school office after submission of a copy of the payment receipt.

Registration for Disadvantage group & Special category candidates may be done at the Govt. portal www.rteparadarshi.odisha.gov.in free of cost.

25% of the seats as per **RCFCE Act 2009** are reserved for the candidates belonging to weaker sections and disadvantaged group of the society in the neighborhood (**within 01 K. M. of the school**).

- Photocopy of Birth Certificate issued by the competent authority.
- B2 size (7cm x 5 cm) photograph of the child along with the parents at the space provided.
- Documents required for Disadvantaged Group (SC/ST/SEBC-Non-Creamy Layer) & Economically Weaker Section**
 - Birth certificate issued by competent authority.

- (b) Identity Proof of Parents/Guardian (Aadhar Card/Voter Id/Kisan Photo Passbook/Ration Card/PAN Card/MNREGA job Card/Passport/Photo attested by any Gazetted Officer/Disability Certificate issued by competent authority).
- (c) Caste certificate issued by competent authority in case of Sc/ST/SEBC.
- (d) Address Proof (Aadhar Card/ Ration Card/Bank statement or passbook/ Voter Id/Driving License/Gas connection bill which is not more than 3 months old/Farmer Photo Passbook (KCC card)/Registered Lease/Sale/Rent Agreement/MGNREGA Job Card/Passport/Certificate in support of address given by Sarapanach/ Counsellor/Corporator/ Labour Card/the certificate in support of address given by local MLA/ Gazetted Officer written on their letterhead).
- (e) Any poverty alleviation card issued by Govt./Certificate of income issued by the Competent authority in case of EWS candidates.
- (f) Disability Certificate/ HIV positive certificate (in case of parents) issued by the Competent authority in case of Children with disabilities (not less than 40%)/HIV positive of the parent(s).
- (g) CWC certificate.
- (h) Photo copy of application form applied through RTE-Paradarshi portal.
